Political Education Chair Message

Friends,

With minds concentrated on the 25th anniversary of The Good Friday Agreement (10 April 1998), some developments took place this month related to the conflict over Northern Ireland (NI) Protocol.

Development #1: UK and EU appear to be on brink of new Brexit deal. According to reports, UK Prime Minster Sunak and EU Commission president Ursula von der Leyen spoke by telephone on Feb 23rd and Downing Street said the prime minister had made "good progress". Meanwhile, UK Foreign Secretary James Cleverly has pulled out of a long-planned trip to the Middle East: raising expectations that a formal announcement from the UK and Brussels could be days away.

- Today, a single channel exists for goods traded between the UK & NI and all items must go through a customs check. In the new plan, the green channel would allow good intended only for NI to go through without checks, while a red channel would be used for items intended for further import into the EU form NI.
- No news on the second controversial point of the NI Protocol: the role of the European Court of Justice in resolving disputes. That will be a trickier point for politicians to finesse.

Development #2: Further pushing the UK to negotiate, the UK Supreme Court ruled on Feb 8th that <u>the NI Protocol is lawful</u>. As part of the Brexit deal, the NI protocol creates a trade border between Northern Ireland and the rest of the UK. The unionist case against the protocol asserted three aspects:

The court unanimously rejected their appeal on all grounds. It had previously been rejected by the High Court and Court of Appeal.

7 Surprising Facts about St. Patrick's Day

- 1. The real St. Patrick was born in Britain. It is believed that at age 16 he was kidnapped by Irish raiders and sold into slavery in the North. He later escaped back to Britain eventually returning back to Ireland as a Christian missionary.
- 2. There were no snakes around for St. Patrick to banish from Ireland.
- 3. Leprechauns are likely based on Celtic belief in fairies. The original name for these figures is lobaircin, meaning small-bodied fellow.
- 4. The shamrock was considered a Sacred plant called a seamroy by the Celts.
- 5. The first St. Patrick's Day parade was held in America. Records indicate that the first parade was held on 17 March 1601 in a Spanish colony in what is now St. Augustine, Florida.
- 6. The Irish were once scorned in America. Note really new to us.
- 7. Corned beef and cabbage is an American innovation. While ham and cabbage are the staple in Ireland.






