#### **Political Education Chair Message**

The "Legacy and Reconciliation Bill" (click <u>this link</u> for context) continues to advance. The House of Lords (like our US Senate) voted to strip out offering immunity from prosecution to those who committed crimes during the Troubles if they co-operate with a new truth-recovery body. The Northern Ireland Secretary, Chris Heaton-Harris, said <u>the British government cannot accept the amendment to remove the clause</u> offering conditional immunity from prosecution. He insisted the British government's proposed legacy Bill "will finally provide answers" for many victims, survivors and families bereaved during the Troubles in the North. When the versions from the House of Lords and House of Commons went to committee, when the MPs voted 292 to 200, majority 92, to disagree with this change and to restore the measures. Full summary here.

After the vote, Heaton-Harris indicated in July that <u>he was confident</u> controversial Bill would receive royal assent. The Bill <u>is expected to gain Royal Assent this</u> <u>autumn</u> despite being opposed by all major Stormont parties, the Irish Government and victims' campaign groups.

The pushback on this egregious act and committee action drew pushback from all fronts.

Sixteen members of the <u>United States House of Representatives</u>, from both parties, wrote to British Prime Minister Rishi Sunak, Northern Ireland Secretary Chris Heaton-Harris, and the British Ambassador to the US, Karen Pierce, raising profound concern over the Legacy Bill.

The Ancient Order of Hibernians (AOH: us) continued its critical opposition against the bill.

In a statement this week, AOH National President Daniel O'Connell said that Chris Heaton-Harris had stated that the U.K. Government plans to continue its "ill advised pursuit" of the Northern Ireland Troubles (Legacy and Reconciliation) Bill, restoring to the bill provisions that would provide an amnesty for murder and torture, halt current and future investigations, and deny victims access to the courts. AOH National FFAI chair Martin Galvin who published a letter in this week's IRISH NEWS, the largest selling daily paper in the six counties of Northern Ireland to an article submitted by Trevor Ringland who served as a British Government Special Envoy to the US. Martin's full letter <u>is here</u> and <u>on this</u> <u>Facebook page</u> (for easier forwarding to your division membership via Facebook).

Declan Morgan, the retired judge who will head the commission investigating the legacy issues, said the task of dealing with the legacy of the Troubles in Northern Ireland has been avoided due to lack of will. <u>This informative article</u> recounts the initial work in 1998 (when the Good Friday Agreement was signed), the attempt in 2009 through Eames/Bradley to do something about it, which also foundered, and the Stormont House Agreement 2014 which never come into force.


